## The Personal Data Hasu Capital and Hasu Digital Collects

### (a) Non-Personal Information

- (ii) Information collected from the devices you access our website and may include your usage patterns, time of visiting, referring site details, type of browser and operating system, IP address, site interactions, geological information and similar data.

### (b) Personal Information

#### (i) Identifiable Information

Full name, postal address, email address, phone number, ID/ passport number and information of a similar nature.

#### (ii) Financial And Transactional Data

Includes bank account, payment card details and transactional information between you and Hasu Capital when you purchase our products and services.
